WHEREAS, Nina Pryatel is a member and past President of the Friends of the San Marcos Library and a tutor in the library's Adult Literacy programs; has served as a mentor for children in our public schools; an advisor to the Regional Red Cross; a reserve nurse for the Armed Services; a leader of the Greater San Marcos Neighborhood Council; and a volunteer at the Tourist Information Center; and

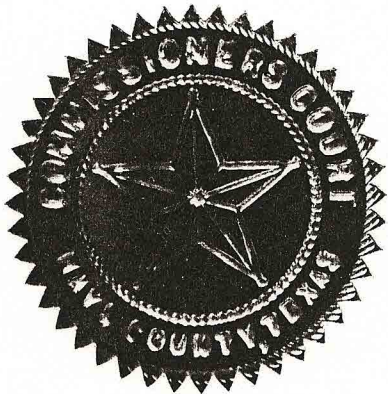

WHEREAS, Nina Pryatel serves as a volunteer at the Hays-Caldwell Women's Center, as a passionate advocate for women's rights; as a tutor in adult literacy programs at the Library; as a mentor for children in our Public Schools; as an advisor for the regional Red Cross; as a reserve nurse for the Armed Services; as a leader of the Greater San Marcos Neighborhood Council; and as a volunteer at the Tourist Information Center; and
